- 1.4. Discounts based on bulk filings are available upon request, usually for ten or more simultaneous filings.
- 1.5. Invoices are payable within 30 days.

The following documents and information are required for trademark applications:

- ➤ sign (word mark, for a trademark with logo, we need one representation if colours are claimed one in colour with specification of colour in words or internationally accepted colour codes such as Pantone, RAL or NCS that can be transmitted electronically (in jpg. format, max. 300KB);
- list of goods/services;
- applicant's particulars;
- > POA (for our files, the IPO does usually not ask for a POA, it may be sent to us by e-mail or fax, no notarisation, no legalisation);
- priority information (optional).

#### Delivery time
